## **HOA Annual Meeting**

- Neighborhood Update
  - O Need to get complete neighborhood contact list.
  - Eco pass. How many people needed for eco pass to get good conditions. Kathy to talk to Ellen.
  - o Susan wants to continue newsletter going forward.
- Landscaping report
  - o The sprinkler system was winterized. Actual use of irrigation water was below budget due to weather adjustments of the controllers. Two major breaks of the line along the medians were repaired.
  - O All common areas were cleaned up for about \$1000. In addition, drains along WMC cleaned and leaves removed in all common areas. Some homeowners disposed their leaves on common areas. However HOA is not responsible for leaf removal.
  - o No parking sign located in front of our East common area was moved to prevent cars obstructing the entrance of our common area.
  - There is a homeless camp on berm behind 4838 West Moorhead could be fire hazard. Kathy to call CU police and send letter.
  - o 4-5 inch of snow on cul-de-sac trigger HOA snow removal. So far, we reached more than 4 inch only one time; sidewalks were cleaned with the cul-de-sac for \$950. Massimo requested cost to clean the sidewalks even when we do not have 4-5 inch of snow.

- When letter to homeowners is sent out in spring, we will include how the HOA spends the dues. We will also make a webpage showing our common areas and what has been done.
- Dead trees near 1095 TPC, along the small ditch, could be removed or pruned. Massimo to see what the cost would be.
- Another two trees along the ditch need to be treated for Ash borer...
- Treasurer's report;
  - o Discussion of 2023 budget; set 2024 dues: Have seven homeowners who have not paid dues yet.
  - o Looking good actual vs budget. In the green. Didn't use a lot of water so saved money there.
  - o Rat control has significantly reduced population.
  - o Good budget year. Have double annual budget on hand. In good spot.
